### Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows: forming assessment:

- knowledge is verified by short tests after the third and fifth didactic unit - short test and problem tasks;

- social skills and competences are verified by issuing partial grades resulting from: teamwork; rewarding activity; independent problem solving.

## Summative rating:

knowledge is verified by an oral exam on basic concepts related to human functioning in the work environment, including occupational health problems, methodology for diagnosing these problems and legal classification of occupational disease;

classes - average partial grades + grade from the preventive action plan prepared by students in the workplace.

#### **Programme content**

1. Health - a historical outline, evolution of the concept, modern approaches (biomedical, holistic, A. Antonovsky's salutogenesis model, homeostasis vs. homeodynamics). Health determinants according to Marc Lalonde. 2. Basics of the physiology of the human body. Selected issues of biomechanics and anthropometry. 3. Occupational disease as a medical and legal concept. Impact of harmful and arduous factors in the work environment. Hazard analysis at the workplace. Occupational disease - the process of recognition and adjudication. 4. Occupational diseases resulting from the effects of factors harmful to the work environment. Review, incidence distribution, change trends. 5. Occupational diseases caused by the way the work is performed. Ergonomic risk factors. Work related illnesses. 6. Pathologies of the working environment as a threat to mental health. Stress and its consequences, addictions in the workplace. 7. Health prevention. Popularization of the concept of health promotion in the workplace. Shaping a health safety culture.
