Prerequisites

The student should have basic knowledge on the state system at the level of secondary school graduation, the ability to think logically and practical skills in the search for basic literature available in print and in the Internet, as well as understand the importance of legal and institutional regulatory mechanisms in social life and the economy.

Course objective

Providing students with basic knowledge on the legal system and branches of law.

Course-related learning outcomes

Knowledge

The student knows the basic concepts and principles of the main branches of law, with particular emphasis on civil (substantive) law [P6S_WG_01],

- has basic knowledge of legal norms, their sources, nature, changes and ways of affecting the organization in terms of its forms and principles of the organization's functioning [P6S_WG_02],

- has basic knowledge on the national legal system and its internal structure (branches of law) as well as the institutions and sources of EU law [P6S_WG_05],

- has basic knowledge of the nature of management sciences and their place and connections with legal sciences [P6S_WG_11].

Skills

The student is able to use the basic theoretical knowledge and find the applicable legal regulations to analyze specific legal problems in the field of management [P6S_UW_01],

- can link problems to main branches, legal acts and institutions as well as make a general assessment of management problems in terms of applicable legal norms [P6S_UW_06], [P6S_UW_07],

- correctly uses normative systems and selected legal norms in order to solve a specific task in the field of management [P6S_UW_08].

Social competences

The student perceives interpersonal relations in the organization from the perspective of ethical and legal norms; demonstrates care for the performance of professional duties with respect for law [P6S_KR_02].

Methods for verifying learning outcomes and assessment criteria

Learning outcomes presented above are verified as follows:

Formative assessment: discussions summarizing particular lectures and tutorials, solving legal problems during the classes that offers the opportunity to assess the student's understanding of the issues raised.

Summative assessment: the knowledge acquired in tutorials is verified in a written test carried out in the last class. The knowledge acquired in lectures is verified in a written exam.

Programme content

Lectures:

Introduction to jurisprudence - legal system, branches of law, composition and types of legal norms, application of legal norms in time and space.

Sources of national universally-binding national law - law making, hierarchy. Competences of the Constitutional Tribunal. Rules for lodging a constitutional complaint.

The institutional and legal system of the European Union.

Justice system in Poland. Elements of civil proceedings.

Criminal law: the concept of an offence, principles of criminal liability.

Administrative law: government and self-government administration, legal forms of activity of public administration.

Labor law: characteristics of the employment relationship, employment contract - form and content, types of employment contracts, comparison of the employment contract with civil law contracts.

Tutorials:

Legal entities: a natural person, a legal person and the so-called imperfect legal entity. Legal capacity and capacity for acts in law.

Power of attorney

Legal actions - concept, types, forms; defects of declartion of intent.

Limitation of claims

Proprietary law: characteristics of proprietary rights, concept and types of things. Ownership right - content, limits, acquisition and loss. Land and Mortgage Registers - a guarantee of public faith in land and mortgage registers.

Law of succession: statutory and testamentary inheritance. Acquisition and rejection of the inheritance.

Matrimonial property regimes.

Contract law: mandate contract and contract for specific work.
