In addition, the goal was to present knowledge on the protection of industrial

property, purification technology, solvents used in chemical technology, as well as conducting reactions using phase transfer catalysis techniques and with the using of microwaves and ultrasounds.

# **Course-related learning outcomes**

### Knowledge

The student has knowledge of complex chemical processes, including the appropriate selection of materials, raw materials, methods, techniques, apparatus and equipment for carrying out chemical processes and characterizing the products obtained (K\_W3).

### Methods for verifying learning outcomes and assessment criteria

### Learning outcomes presented above are verified as follows:

Knowledge acquired during the lecture is verified on the basis of the final written test. Passing threshold: 50% of points. Depending on the situation, two forms of the exam will be possible during the exam session: stationary and remote.
